At a regular meeting of the Township Board for Lowell Charter Township held at the Township Offices on June 20, 2022, Township Board Member Thompson made a motion, seconded by Township Board Member Benedict to adopt this Zoning Ordinance amendment:

AN ORDINANCE TO AMEND THE LOWELL CHARTER TOWNSHIP ZONING ORDINANCE BY DELETING SECTION 4.22, PUBLIC SHOWS AND SIMILAR OUTDOOR ASSEMBLY EVENTS.

THE CHARTER TOWNSHIP OF LOWELL ORDAINS:

<u>ARTICLE 1.</u> Section 4.22 of the Lowell Charter Township Zoning Ordinance, Public Shows and Similar Outdoor Assembly Events, which follows, is hereby **DELETED** and this Section is reserved for future use.

SEC 4.22 PUBLIC SHOWS AND SIMILAR OUTDOOR ASSEMBLY EVENTS Public Shows, Etc.

- Public shows, meetings, entertainments, exhibitions, competitive events or religious services and similar outdoor assembly events may not be held in the open air or under canvas unless a written application is first filed with the Township Clerk and a license be obtained therefore. Said application shall state the name or names of the applicant or applicants and the nature of the activity and the proposed site. The Township Clerk shall grant a license upon proper application, if it appears that such activity is not in violation of any law, ordinance or regulation and will not endanger the public peace, health, or safety. (10 Jan, 81) (Also see Lowell Charter Township Outdoor Assembly Ordinance No. III if event is over 1,000 persons.

ARTICLE 2. Severability. Should any portion of this Ordinance /ordinance amendment be declared by a court of competent jurisdiction to be invalid or unconstitutional, that shall not affect the balance of this Ordinance/ordinance amendment, which shall remain in full force and effect.

ARTICLE 3. Effective Date. This Ordinance/ordinance amendment shall become effective seven days after its publication or seven days after the publication of a summary of its provisions in a local newspaper of general circulation.
